


The multiple African champion who was accompanied by coach Akuh Purity will take to the mat on Friday against high profile wrestlers in the world that missed out in their regional windows.

he Nigeria Football Federation has revealed the reason behind its decision to appoint Finidi George head coach of the Super Eagles.

Finidi was announced as Jose Peseiro's predecessor last week.

Director of Communications, Nigeria Football Federation (NFF), Ademola Olajire said the 53-year-old's impressive track record and experience of working with Peseiro made him a stand-

out choice for the job.

"I'm not a member of the Technical Committee but I can also look at a lot of positives around Finidi George." Olajire told Hotsports.

"Finidi George was not only a great football player, he has prepared himself very well and done himself no harm with the laurels he has been able to acquire in his short period as a coach.

"He had the option of remaining in Spain and taking up an appointment with a second tier club but he chose to come back to Nigeria and start

with an NPFL club.

"He started with Enyimba. In his second season, he won the league title. It is not easy to win the league title so we must praise him for that and looking at the log now, this is his third season with the team and with four matches to go he's well on the way to retaining the title.


"That is no mean feat and it shows that this is a man who knows what he's doing.

"Pertaining to the Super Eagles, he worked for twenty months as an assistant with Jose Pe-



he board of the Nigeria Professional Football League the other day announced that all league fixtures will be postponed for a month,

The announcement was made to allow Rivers United to complete their outstanding games on or before May 18. A week's break will ensue before all 20 teams resume on the 25th of May. In a memo released by the NPFL Chief Operating Officer, Davidson Owumi, it was stated that the league was put on hold to provide a level playing platform for all teams going into the last six fixtures of the season

Meanwhile Rivers United wrote to the chief operating officer of the NPFL, Threatening to pull out from all football related activities, because they are not given fair treatment considering how much they've invested in the league.

First of all, the inconsistency of our league matches and abrupt change in fixtures does more harm than good to our league in general and also sometimes affects teams who are struggling financially to execute their games.

The Nigerian Premier Football league is



of age and should be handled professionally both on and off the pitch,

Coming to the arrangement of fixtures, fixtures should be arranged putting in con-

sideration the international engagements and other compulsory competitions, so that outstanding games will reduce thereby bringing balance to league.

Finidi, Cry No More

renched in tears invisible since the passage of younger brother, Igeniwari, new Super Eagles coach, Finidi George, deserves honours for believing in self and country. This journey to the plum job was full of twists, turns, bruises and blood.

Igeniwari died on September 9, 1995, playing for Enugu Rangers. It was in Ibadan following their 1-0 victory over Stationary Stores, in a Challenge Cup game. He was part of the Golden Eaglets squad to the Ecuador '95 FIFA Under 17 Championships. That was the year Finidi won the UEFA Champions League with Ajax.

From ecstasy, the George family went into agony. The trauma was compounded because till date, there is no official pronouncement on who killed Igeniwari. Twice, Finidi flew back home from Amsterdam but was not allowed to see his brother's body, by the police.

Some of us thought the bullet that killed him came from Stores supporters who went wild after the referee awarded Rangers a penalty in the 87th minute. The result was a 1-0 victory for the Flying Antelopes. However, Adetilewa Adebajo, one of the owners of the Lagos club argues otherwise.

He wrote: "The bullet that killed Igeniwari, was allegedly fired by the Aide De Camp (ADC) to a Military Administrator, whose car was coming from behind the Rangers bus. It's movement had been blocked by the throng of supporters (Rangers and Stores supporters), all trying to exit the stadium."

According to Adebajo,"To disperse the supporters, the ADC came out of the car, in an attempt to fire into the air but his gun discharged half way up. Igeniwari was seated at the rear of the bus and unfortunately, took the bullet. NFF banned Stores as a scape goat."

Adebajo admitted that he was not at the stadium but as a stakeholder, got information from those who should know. Police investigations did not yield any official statement. NFF later unbanned Stores after much pressure.

There is also another version that blames the Police for the tragedy. "The police used live ammunition to control the crowd. More than one person died although it was reported that only Igeniwari died." The painful part was that Finidi could not grace his brother's funeral

It has been a hard road to the top. Finidi's Eagles debut was sweet and sour. He scored the last goal, three minutes to time in the 7-1 demolition of Etalons of Burkina Faso. That



was the day the Eagles cut their long pants because an NFF official forgot to bring their shorts to Sportscity.

Finidi came in for Austin Eguavoen. The game cost NFF chairman, Yusuf Ali, his job. Secretary General, Patrick Okpomo, resigned. The Burkinabes who got a 1-1 result in Ouagadougou earlier, were taunted as 'Burkina Suffer' by Nigerian fans.

From that first cap on July 27, 1991, Clemens Westerhof stuck to Finidi. It was no surprise that Ajax snapped him in 1993. Until the winger moved to Real Betis in 1996, Ajax remained Dutch champions, three times consecutively. He also played for Mallorca and Ipswich.

Finidi scored the goal that took the Eagles to their first World Cup, USA 1994. His 20th minute strike in Algeria lasted for 70 minutes before the hosts equalised. A 1-1 ending was perfect. And he graced the Mundial twice, from America to France.

This same star was denied a third World Cup opportunity as Vice Captain to Sunday Oliseh.

After losing to Senegal in the semis of

the Mali 2002 African Nations Cup, the NFF felt the captain was a bad influence on the team with what was seen as little respect for government officials. Coach Shuaibu Amodu was sacked and replaced by Adegboye Onigbinde who overhauled the team to Korea/Japan 2002.

Finidi would always prove himself. While playing for Calabar Rovers against ACB in the Nigerian league, he got the winning goal three minutes to the final whistle. Rovers Chairman, Rowland Obu, had asked for the player's substitution but the coach refused.

From Government Comprehensive Secondary School, Borokiri, Finidi joined Agip in 1985. Two years later he crossed over to NNPC, Port Harcourt. After one season, Sharks grabbed him in 1988.

I met Finidi for the first time in 1990. He was one of the Local Leaguers kept busy at the Eagles' Otta Farm Camp of Dr. Olusegun Obasanjo, by coach Tunde Disu, under the supervision of Westerhof. The Sharks player always moved around with team mates Eson Osagie and Fubara Owunaro. Goddy Eke and Amir Angwe, were also there.

This experience will help him in managing the Super Eagles. As coach of Enyimba, Finidi understands the Nigerian Premier League better than his European predecessors who chose to operate from overseas.

Finito is not the noisy type but will brook no indiscipline. He has more trophies in his room, than any player under his charge - African Nations Cup. The Toyota World Championships Cup. UEFA Super Cup and Champions League. Double World Cup Appearance.

Perhaps, Igeniwari would have done well outside Africa like his Ecuador '95 contemporaries, Stephen Appiah, Tim Howard, Harry Kewell, Shinji Ono, Brett Emerton and Junichi Inamoto. Ecuador highlighted some football families - Amuneke Kingsley, Yobo Albert, Oruma Johnson and Igwilo James.

Finidi still has elder brother, Alari, who also played good soccer, around. The Kerekese are proud of yet another son, after giving Nigeria Adokiye Amiesimaka and Richard Owubokiri. For a man who never turned his back on Nigeria, this is his time to shine.

Maradona's Golden Ball Trophy At World Cup Goes For Salepublished 25 Mins Ago On May 7, 2024



iego Maradona's Golden Ball trophy won for being named the best player at the 1986 World Cup will be auctioned in France in June, the Aguttes auction house said on Tuesday.

This is the first Golden Ball to go for auction and while the value is still to be confirmed, the auction house expects it to fetch millions on June 6.

Maradona, who died in 2020, won the award after leading Argentina to World Cup victory in Mexico, scoring five goals at the finals where he captained his country and played every minute of the tournament.

That tournament is probably best remembered for Maradona's two goals against England in the quarter-finals.

Maradona outjumped England keeper Peter Shilton as he thumped in the first goal with a raised fist, which he later dubbed as being scored by the "Hand of God".

The second was an incredible mazy slalom run from his own half, when he dribbled past five English outfield players, and was voted as the "Goal of the Century"

The jersey he wore that day, along with the ball from the match, have both previously been sold at auction.

After his display against England, Maradona went on to score the two goals which defeated Belgium in the semi-final and Argentina won a thrilling final 3-2 against West Germany.

The Golden Ball award was introduced at the 1982 World Cup, and its list of winners include Italy's Paolo Rossi, Romario and Ronaldo of Brazil, Zinedine Zidane of France, while Argentine great Lionel Messi is the only player to have won the accolade twice.

Maradona's award had disappeared before resurfacing among several trophy lots in an auction room.

ndo State Commissioner, Youths Development and sports, Hon. Saka Yusuf-Ogunleye has promised to improve the welfare of players and backroom staff to enhance productivity.

Yusuf-Ogunleye made the assertion when he met with players, technical crew and backroom staff of Sunshine Stars FC at the games village in Oda road, Akure.

The commissioner opined that it became important to meet with the team and address challenges and offer immediate solutions geared towards getting desired results.

He commended the players for their beautiful displays against Shooting Stars stars FC in Ibadan, but cautioned against complacency in defense in their subsequent matches.

" Indiscipline in different spheres brought us to this level despite having some quality players in our team, an end has come to that," he said

Yusuf-Ogunleye said he will look into the issues of Fake Registration, Betting and others that had been alleged to have affected the team negatively.

"The challenges will be addressed and those acts of insubordination and indiscipline will be a thing of the past. Moreso, let me quickly inform you all that I will increase your match bonus, feeding allowance will also be be increased and other entitlements will improve," he said

The commissioner directed that electricity should be restored at the team's camp while placing a ban on players boarding a bike to training sessions



"It's shocking to hear you players talk about the bad state of your hostel, from this moment, it will be conducive, electricity will be restored from today and please let me notify everyone here, An end has come to players taking bike to training sessions, you are professionals and it's time to treat you as real professionals," he added.

On issues raised by some players that they

were abandoned each time they got injured in line of duty and bills for their treatment not attended to by the team officials, the commissioner said it was pathetic to hear such and gave a direct approval for the payment of all medical bills of injured players.

"Please let it be on record that no player should be allowed to treat himself with his money after sustaining injury , and from today an improvement has come to the medical team in terms of money." He added

Saka Yusuf, approved the release of funds for the purchase of drugs for the medical team of the agency.

On the issue of money not released to backroom staff to keep Jerseys of players clean as authorised by the management, he ordered the immediate approval that such an amount should be paid directly into the account of the staff in charge.

The commissioner directed immediate repair of vehicles on or before Thursday.

Furthermore, he directed the coaches to submit list of regular players promising to reduce the number of players from 52 to a reasonable size .

He urged players tagged "Political" to exit the club as Sunshine Stars FC is not a party secretariat. He said politics should not be prioritized ahead

of results. He said the Football Agency isn't a charity

nome.

"Throughout the county there isn't a state that

has a football agency, we have and we are most the least on the log, poor management of the agency has led to the challenges we are facing but we shall overcome," he noted.

The commissioner, also set up a committee to look at the scouting and transfer of players in the U-17 team.

He advised those redeployed to the U-17 team and Sunshine Queens to resume saying," Change is the only thing that is Constant."
